- 1. Agreement with Cooperative Education Services (CES), to provide onsite direct cognitive and academic testing, rating scales assessment and social emotional rating scales assessments from February 8, 2021 to June 30, 2021 in an amount not to exceed \$37,500.00.
- 2. Amendment #1 to Agreement #96293541 with Center for Collaborative Classroom to change the start date of service from September 15, 2020 to August 31, 2020 with no change in funding amount.
- 3. Agreement with Connecticut Science Center to provide coaching support and a Next Generation Science Standards workshop to teachers at Davis and King-Robinson schools, from February 8, 2021 to June 30, 2021, in an amount not to exceed \$40,000.00.
