DESCRIPTION AND NEED FOR AMENDMENT: Bodyworks will increase physical and mental activities in the Troup afterschool program with a focus on Zumba fitness. The amendment is needed to increase Bodyworkers sessions at Troup school. Bodyworkers will provide 73 sessions at Davis, 36 sessions at Troup and add an additional 30 one hour sessions (30 x 150 = \$4,500.00) at Troup for a total of 139 one hour sessions.

Youth Family and Community Engagement

This Agreement entered into on the 14th day of September 2020, effective (*no sooner than the day after Board of Education Approval*), the 14th day of September, 2020, by and between the New Haven Board of Education (herein referred to as the "Board" and, Bodyworkers LLC, located at, 121 Read St, New Haven CT, 06511 (herein referred to as the "Contractor").

Compensation: The Board shall pay the contractor for satisfactory performance of services required the amount of \$150.00 x 109 sessions, for a total of **\$16,350.00**.

The maximum amount the contractor shall be paid under this agreement: sixteen-thousand three hundred –fifty dollars and zero cents (**\$16,350.00**). Compensation will be made upon submission of an itemized invoice which includes a detailed description of work performed, attendance sheets, and date(s) of service.

Fiscal support for this Agreement shall be by the **21st Century and Extended School Hours Programs** of the New Haven Board of Education,

This agreement shall remain in effect from September 14, 2020 to June 30, 2021.



Further, the Contractor covenants and agrees that it shall hold the Board and its members, employees and agents harmless against any and all claims, suits judgments of any description whatsoever caused by the Contractor' breach of this agreement or based upon the conduct of the Contractor, or its agents or its employees or arising out of in connection with their activities under this agreement.

TERMINATION: The Board may cancel this agreement for any reason upon thirty (30) days' written notice sent to the Contractor by certified U.S. mail, return receipt requested; provided however, that the Board shall be responsible to the Contractor for all services rendered by the Contractor through the last day of thirty (30) day notice period, as long as the Agreement was approved by the Board prior to the start date of service.
