Lonnie Garris former teacher, coach and long standing principal of Hillhouse High School, went above and beyond for his students; and implemented the "We can't teach an empty seat" Attendance Policy. It is requested the Foyer of Hillhouse be memorialized in his memory.

In regards to funding of the plaques for these individuals. Mr. Pinto states he will discuss with Gilbane construction for a recommendation, since one is needed for Obama School as well. Since the dedication was postponed due to Covid. He will check possible available Capital funds if possible and get back to the committee.
