Notification received December 9, 2019, Grant 01CH010905, continuation of 5 year grant, Year 2

- Same funding and enrollment as Year 1
 - Program Operations-\$ 5,676,564
 - Training &TA \$ 66,934
 - Total \$ 5,743,498 Funded enrollment- 531 students
- Notification NHPS Head Start Program has satisfied the corrective action regarding child guidance, active supervision and safe transportation
- > Notification of non-compliance for failure to secure a mental health provider for the program
- Liz Gaffney was accepted into PMFO New Director Mentee Initiative, will attend professional development at UCLA from March 3-5, 2020

IV. Non-Compliance; Mental Health Contract

- > During the recent monitoring event, as a result of failure to secure a mental health contract during the past year, the Head Start Program was issued a non-compliance
- ➤ 1302.45 (a)(2) Child mental health and social and emotional well-being- A program must secure mental health consultation services on a schedule of sufficient and consistent frequency to ensure a mental health consultant is available to partner with staff and families in a timely and effective manner
- > The program has 120 days to rectify- satisfaction due date: May 12, 2020
- Quotations for services have been requested from the following agencies

 - Cornell Scott Hill Health Center
 - Yale Child Study Center
 - Stakeholder input will be sought from Policy Council
 - Selection process will be shared with Policy Council and a special meeting will be held if necessary
