322-20 **Approval of Minutes** 6/8/08/20 Meeting

On the motion by Dr. Joyner, seconded by Mr. Wilcox, it was unanimously voted, by roll call, with one abstention by Mr. Conaway who was not at the meeting, to approve the Board Meeting Minutes of June 8, 2020, with corrections.

Appoint Ms. Ivelise Velázguez, Assistant Superintendent of Curriculum Instruction and Assessment

Dr. Joyner made a motion on the recommendation of the Superintendent that the Board hereby appoint Ms. Ivelise Velázquez to serve as Assistant Superintendent of Curriculum Instruction and Assessment; and further move that the Board authorizes the Superintendent and the Board Chair to sign the related contract of employment of Ms. Ivelise Velázquez on behalf of the Board. Mrs. Rivera seconded the motion.

324-20 **Amend Contract to Postpone Signing**

On the motion by Mr. Goldson, seconded by Mr. Conaway, it was unanimously voted, by roll call with three ayes and four nays, to amend the contract to postpone the signing of the contract of Ms. Ivelise Velázquez until further review.

325-20 **Postpone Original Motion to Appoint** Ms. Ivelise Velázguez On the motion by Mr. Goldson, seconded by Mr. Conaway, it was voted by roll call with 4 nays and 3 ayes, to postpone the original motion to appoint the hiring of Ms. Ivelise Velázquez to the next Board meeting. Motion did not pass.
