The NHBOE It will allow the sale to students of food items that do not meet the Connecticut Nutrition Standards provided that the following conditions are met: 1) the sale is in connection with an event occurring after the end of the regular school day or on the weekend; 2) the sale is at the location of the event; and 3) the food items are not sold from a vending machine or school store. An "event" is an occurrence that involves more than just a regularly scheduled practice, meeting, or extracurricular activity. For example, soccer games, school plays, and interscholastic debates are events but soccer practices, play rehearsals, and debate team meetings are not. The "regular school day" is the period from midnight before to 30 minutes after the end of the official school day. "Location" means where the event is being held and must be the same place as the food sales. "

The HFC statement it is part of the CT State Department of Education's Online Application and Claiming Systems for Child Nutrition Programs. Hard copies of the form are no longer required but statement must be presented and approved by vote from the school district board of education.

The Food Service Director shall be responsible for the education of all food handlers as to personal hygiene and techniques of sanitation.

All cafeteria workers shall be required to have a physical examination at the time of employment and periodically as requested by the School Medical Advisor.

#### Financing

The school lunch program shall be financed as follows:

1. If meal prices are needed, prices of school lunches shall be determined by the Superintendent in accordance with all prevailing costs of food, supplies, supervision costs, and wages of hourly workers.

2. Costs of food, supplies, salaries and wages of all employees, and other expenses directly incurred in the school lunch program shall be paid out of a separate fund, which shall be maintained under the control of the Business Manager or his/her designee and into which all receipts from sales and federal cash grants shall be paid. This fund shall be subject to annual audit by the District auditor. In compliance with federal law, the District's NSLP (and SBP) shall be non-profit.

3. Office facilities, equipment, heat, light and power shall be paid out of funds appropriated by the Board of Education.

4. Although the Board believes that the District's nutrition and food services operation should be financially self-supporting, it recognizes, however, that the nutrition program is an essential educational and support activity. Therefore, budget neutrality or profit generation must not take precedence over the

Authorization is granted to the Superintendent to act on behalf of the Board for purposes of participating in the National School Lunch Program (and School Breakfast Program).

Free nutritious meals will be served to children from families whose income falls within the current criteria established by the Secretary of Agriculture under the Federal Lunch Program for free lunches.

National School Lunch Program (NSLP) regulations require that lunches be provided for needy students when the family income is insufficient to provide the basic necessities, including food of the proper quality and amount for good nutrition.

Parents shall be informed of the District policy concerning "Meals for Needy Children." A letter and application form will be distributed to all parents during the first few weeks of school. The letter will contain information on the eligibility standards, procedures for applying for free "Meals for Needy Children," and how an appeal may be filed for an adjustment in the decision with respect to the application. This information and an application form will also be provided whenever a new student is enrolled. (cf. 3542.42 Finance: Food Service)

A public news release containing this same information will be made available to local news representatives early in the school year. Copies of this public release will be made available upon request to any interested party. Subsequent changes in the district eligibility standards during the school year, which are approved by the state agency, will also be publicly announced.

1. Free or reduced price lunches and/or supplementary milk will be provided for all students who qualify on the basis of financial need. Breakfast snacks may be provided in cases of extreme nutritional deficiency.

2. There shall be no discrimination in the furnishings of meals or supplementary milk because of race, religion, source of income, etc.

3. The anonymity of students receiving assistance under this regulation shall be protected. The names of these students will be treated in a confidential manner. They will use the same tickets for milk and lunch and will obtain these items in the same manner and place as do all other children.

4. Requests for free lunches, reduced price lunches, and/or supplementary milk which have been denied may be appealed to the Superintendent.

5. Records of students receiving assistance will be kept in each school. A monthly report will be submitted to the district office where records for audit purposes will be maintained.

6. Annually the District will establish process for reimbursable student meals. The price charged to students who do not qualify for free or reduced price meals will be established annually by the District in compliance with state and federal laws. *(Note: The new requirement under Healthy, Hunger-Free Kids Act of 2010, 42 U.S.C. 1751 §§205 established new criteria for equity in school lunch pricing.)*

7. The price charged to students who qualify for reduced price meals will be established annually by the District in compliance with state and federal laws. (According to Direct Certification and Certification of Homeless, Migrant and Runaway Children for Free School Meals, 7 C.F.R. Part 245, 2011)

8. Eligibility for the "Meals for Needy Children" program will be based on the following:

#### A. Emergency Situations

A child's statement of need is sufficient for providing assistance on a temporary basis. A family contact should be made immediately to determine extent and probable duration of need. In cases of family emergency such as sudden unemployment, illness, death, desertion, etc., assistance will be provided as needed.

#### **B.** Objective Standards of Need

Eligibility for assistance, other than for emergency situations, will be determined on the basis of income and family size as indicated on the scale provided by the district.

9. If school authorities feel that a family's financial situation has changed, and the students are no longer eligible for free meals, a hearing procedure will be used by the Superintendent to challenge the continued eligibility. In the event of such a challenge, the family will be given a reasonable period of time in advance of the hearing to review the information on which the challenge is based. Children will continue to receive free meals until the conclusion of the hearing.

10. On a case-by-case basis, when a student is known to be eligible for free or reduced price meal (or free milk) benefits and the household fails to submit a confidential application, the Superintendent or designee may complete an application for the student documenting how he/she knows the household income qualifies the student for free or reduced price meal benefits. Parents of a student approved for free or reduced price benefits, when application is made for the student by a school official, will be notified of the decision and given the opportunity to decline benefits.

11. Students who do not qualify for free or reduced price meals (or free milk) are eligible to participate in the (SMP) National School Lunch Program (NSLP) (and School Breakfast Program (SBP)) and will be charged "paid" meal (,) (and) (snack) (milk) prices set by the District. "Paid" category students will be treated equally to students receiving free or reduced price benefits in every aspect of the District's NSLP (,) (and) (SMP) (SBP).

# 12. Schools may provide an additional food plan to students, when affordable in accordance with healthy food guidelines.

13. The District has established a fair hearing process under which a household can appeal a decision with respect to the household's application for benefits or any subsequent reduction or termination of benefits.

14. In the event of major employers contemplating large layoffs in the attendance area of the district, the district will provide confidential applications and eligibility criteria for free and reduced price meals (or free milk) to the employer for distribution to affected employees.

#### **Financial Management of the Nonprofit School Food Service**

1. The District will maintain a nonprofit school nutrition and food service operation.

2. Revenues earned by the school nutrition and food services will be used only for the operation or improvement of NSLP (,) (and) (SBP) (SMP).

3. Lunch and breakfast meals served to teachers, administrators, custodians and other adults not directly involved with the operation of the District's nutrition and food services will be priced to cover all direct and indirect cost of preparing and serving the meal.

# (Note: For meals with portion sizes equivalent to student meals, the adult meal price will be not less than the amount of reimbursement for a free-eligible meal, plus the value of commodity foods used in the meal preparation.)



This year we conducted pilot programs in Literacy, Mathematics, and Science curricula. The pilots were conducted because of the necessity to ensure equity and access for all students across the District to a standards-based curricula that provides high-quality resources for teachers and students. Below is a summary of each pilot and the rationale for program selection.

#### Literacy K – 5 Comprehensive Reading Program

Into Reading and ¡Arriba la Lectura! from Houghton Mifflin Harcourt (HMH) has been selected as our comprehensive reading program in grades kindergarten through five.

The decision takes into account feedback from teachers, literacy coaches, school administrators, and parents after a three-month pilot in 12 schools, including biliteracy schools. The pilot featured Into Reading and ¡Arriba la Lectura! by HMH, as well as myView Literacy and miVisión Lectura by SAVVAS.

While teachers in both programs indicated a wealth of resources and high student engagement, HMH was rated higher in key areas:

- The teacher manual and navigation supports were significantly higher-rated by instructors during the HMH pilot.
- Strategies, supports, and activities that address the learning needs of all students, including
  multilingual learners) and students with disabilities, were plentiful and embedded in daily
  lessons.
- Assessment choices will provide a throughline from Grades K-10, utilizing the Growth Measure, which is an updated version of the Reading Inventory. The addition of Amira, the new State Department of Education-authorized universal screener, provides a Dyslexia screener and streamlines assessment requirements for early literacy. This provides guidance for small group instruction while matching resources available within the core classroom. Amira also is customizable for Spanish-speaking students.
- Phonemic awareness lessons in HMH support and enhance the district's current phonics program (Fundations) and follow a systematic order of instruction following the Science of Reading.

#### Math 6 – 8 Middle School Program

iReady has been selected as the middle school math program in grades 6 - 8.

Feedback was provided from teachers, math coaches, assistant principals, and principals to inform this decision. The iReady program and Envisions program were piloted at 23 schools.



NEW HAVEN PUBLIC SCHOOLS

Both programs featured online and print resources and encouraged student discourse, but iReady was rated higher in key areas:

- The Digital platform is very extensive, user-friendly, and teachers have access to all grade levels (K 8) for pre-requisite lessons and differentiation
- The intervention lessons on MyPath are determined by diagnostic results and students are not able to choose their lessons
- Staff has access to individual student growth and proficiency data as well as class and school data for coaches and administrators
- The consultants are very responsive, communicative of program updates and takes our suggestions into consideration when determining professional development needs and supports

### Science 6 – 8 Middle School Program

Smithsonian STMC has been selected as the middle school science program in grades 6 – 8.

Smithsonian STMC, Lab Aids SEPUP, and SAVVAS Elevate Science were piloted in 12 schools. Teacher and administrators provided feedback that informed this decision.

All programs were aligned to the National Generation Science Standards and provided teachers with extensive resources. However, Smithsonian STMC was rated higher in the following key areas:

- Print text is available in English and Spanish and the digital text can be read in both languages
- Program encourages students to engage in discussions, features real-life applications, and links academic vocabulary to activities
- Lessons exhibit natural connections to ELA and math to enhance interdisciplinary learning
- Performance assessments and written assessments are provided at the end of each unit and this affords students the opportunity to show what they know by completing a project/task instead of just a paper and pencil test.

We strongly believe that the addition of the new curricula to our program of studies will improve student outcomes and will prepare them to be future ready.

Re: Non-Certifed Instructors for 2023 Summer of Fun Program

I recommend that the New Haven Board of Education increase the pay rate for Non-Certified Instructors from \$17.50 per hour to \$25.00 per hour for the 2023 Summer School Summer of Fun program. The Non-Certified Instructors hold at least a Bachelors of Arts degree and they play a vital role in the success of the Summer School program. They lead enrichment classes, such as dance, arts and crafts, coding, robotics, journalism, etc., to enhance the learning experiences of children. We also utilize Non-Certified instructors that completed their student teaching and awaiting official teaching certification from the State Department of Education as classroom teachers.

Thus, I believe the recommended increase in pay, in conjunction with the increase in pay for our teachers and paraprofessionals, will ensure that we have a successful 2023 Summer of Fun Program that is well-balanced and fully staffed.

The change in pay for Non-Certified Instructors will revert to existing pay rates once the 2023 Summer, School Summer of Fun program concludes.
