**DESCRIPTION AND NEED FOR AMENDMENT:** The amendment is needed to provide funds for **Our World Care 4 You LLC**. To increase sessions. Our World will increase the number of 2 hour sessions from 219, adding an additional 75 sessions (2 hr. each session) for a total of 294 sessions. This will require an increase in funding from \$43,800 by \$15,000 to a total of \$58,800. The additional 75 sessions will be allocated to Bassett School and the 75 sessions will be funded between the state afterschool grant, which will fund 30 sessions x \$200 (\$6,000) and the ESSER grant which will fund an additional 45 sessions (\$9,000). The ESSER grant will increase funding from \$29,800 by \$9,000 to \$38,800; the number of sessions funded through the ESSER grant will increase from 149 by 45 to 194 (\$200 x 194 = \$38,800).

**DESCRIPTION AND NEED FOR AMENDMENT:** The amendment is needed to provide funds for **Our World Care 4 You LLC**. To increase sessions. Our World will increase the number of 2 hour sessions from 70, adding an additional 149 sessions (2 hr. each session) for a total of 219 sessions. This will require an increase the funding of \$14,000 by \$29,000 to a total of \$43,800. The additional 149 sessions will be allocated as 63 sessions at Davis Street School. \$200.00 per 2 hour session x 63 sessions (\$12,600), 23 sessions at Brennan Rogers School, \$200.00 per 2 hour session x 23 sessions (\$4,600), and 63 sessions at East Rock School. \$200.00 per 2 hour session x 63 sessions (\$12,600).

**FOR DEPARTMENT/PROGRAM:**

**Youth Family and Community Engagement**

This Agreement entered into on the 13 day of September 2021, effective (no sooner than the day after Board of Education Approval), the 14th day of September 2021, by and between the New Haven Board of Education (herein referred to as the "Board" and, Our World. Care 4 Your Own located at, 3000 Whitney Avenue, Hamden CT 06518 (herein referred to as the "Contractor").

**Compensation:** The Board shall pay the contractor for satisfactory performance of services required the amount of \$200.00 per session, for a total of 70 sessions (\$14,000.00).

The maximum amount the contractor shall be paid under this agreement: fourteen thousand dollars and no cents (\$14,000.00). Compensation will be made upon submission of an itemized invoice which includes a detailed description of work performed and date of service.

**Fiscal support** for this Agreement shall be by 21st Century Program of the New Haven Board of Education,

21st Century: 2579-6325-56694 Location Code: 0015 (\$14,000)

This agreement shall remain in effect from September 14, 2021 to June 30, 2022.

**SCOPE OF SERVICE:** *Please provide brief summary of service to be provided.*

The contractor shall provide a school-based afterschool program focused on experimentation and design for the students of Troup School. The sessions will consist of (2) 1 hour activities and serve up to 20 students per session at Troup School. Supplies and instructors

Further, the Contractor covenants and agrees that it shall hold the Board and its members, employees and agents harmless against any and all claims, suits judgments of any description whatsoever caused by the Contractor's breach of this agreement or based upon the conduct of the Contractor, or its agents or its employees or arising out of in connection with their activities under this agreement.

**TERMINATION:** The Board may cancel this agreement for any reason upon thirty (30) days' written notice sent to the Contractor by certified U.S. mail, return receipt requested; provided however, that the Board shall be responsible to the Contractor for all services rendered by the Contractor through the last day of thirty (30) day notice period, as long as the Agreement was approved by the Board prior to the start date of service.
