

# AGREEMENT By And Between The New Haven Board of Education AND

#### New Haven Parks, Recreation and Trees Department FOR DEPARTMENT/PROGRAM: Youth Family and Community Engagement

This Agreement entered into on the 24th day of September, 2019, effective (<u>no sooner than the day after Board of Education Approval</u>), the 24th day of September, 2019, by and between the New Haven Board of Education (herein referred to as the "Board") and, New Haven Parks, Recreation and Trees Department located at, 720 Edgewood Ave, New Haven CT 06515 (herein referred to as the "Contractor").

Compensation: The Board shall pay the contractor for satisfactory performance of services required the amount of 173.33 per day x 111 days at Wexler (\$19,239.63) and 15.00 per hr. for 2-hour shifts, per lifeguard, for up to a maximum of \$120.00 per day for each 2 hr. sessions (\$3,960.00) total amount: (\$23,199.63)

The maximum amount the contractor shall be paid under this agreement: twenty-three thousand - one hundred ninty-nine dollars and sixty-three cents (\$23,199.63) Compensation will be made upon submission of <u>an itemized invoice which includes a detailed description of work performed and date of service.</u>

Fiscal support for this Agreement shall be by 21st Century Program of the New Haven Board of Education,

This agreement shall remain in effect from September 23, 2019, to June 30, 2020.

#### **SCOPE OF SERVICE:**

The City of New Haven Department of Parks, Recreation, and Trees will provide programming four days per week (Monday-Thursday) for 50 students, K-8, in the Wexler 21<sup>st</sup> Century after school program. NHPRT will also provide four lifeguards to staff the pool and support the swimming program for John Martinez after school program from 3pm-5pm twice per week for 37 sessions serving 50 students weekly.

APPROVAL: This Agreement must be approved by the New Haven Board of Education *prior to service start date*. Contactors <u>may begin service no sooner than the day after Board of Education</u> approval.

HOLD HARMLESS: The Contractor shall insure and/or indemnify the Board and its members, employees and agents against all claims, suits, and expenses, including reasonable attorney's fees, in connection with loss of life, bodily injury or property damage arising from any neglect act or omission of the Contractor or its employees or agents. Further, the Contractor covenants and agrees that it shall hold the Board and its members, employees and agents harmless against any and all claims, suits judgments of any description whatsoever caused by the Contractor' breach of this agreement or based upon the conduct of the Contractor, or its agents or its employees or arising out of in connection with their activities under this agreement.

TERMINATION: The Board may cancel this agreement for any reason upon thirty (30) days' written notice sent to the Contractor by certified U.S. mail, return receipt requested; provided however, that the Board shall be responsible to the Contractor for all services rendered by the Contractor through the last day of thirty (30) day notice period, as long as the Agreement was approved by the Board prior to the start date of service.

#### Memorandum

The New Haven Park, Recreation and Trees Department (NHPRT) have provided enrichment activities for New Haven Public Schools for many years. The Agreement, which is being presented today, represents services that were provided at Wexler Grant School during the 2019-20 fiscal school year. The New Haven Parks, Recreation, and Trees Department (NHPRT) provided several enrichment activities for the students at Wexler inclusive of arts & crafts, open gym, dance and supported the theater program. NHPRT staffs provided activities four days per week (Monday through Thursday) to an estimated 50 Wexler Grant students in grades K-8. The initial Agreement was deferred when presented and inadvertently not resubmitted for presentation to the Finance Committee. NHPRT began services on October 7, 2019 under the belief services between city entities only required a memorandum. Another factor influencing the decision to begin was to prevent further delay in providing after school services for students. The delay in processing would have pushed the start date into November of 2019, which would have negatively affected students and families. Prior practices permitted the city department's to sign a memorandum in order to agree to the type of services, length of time, and cost agreed upon between New Haven Public Schools and the New Haven Parks, Recreation, and Trees Department.

This misunderstanding was not intentional and simply intended to provide necessary services for the students and families of Wexler while further allowing NHPS to meet grant requirements regarding the number of days served. The misunderstanding was in no way an attempt to circumvent the Finance Committee nor the Board of Education process.

Thank you for your consideration regarding the request to pay NHPRT for services provided and further Agreements will be submitted according to the established procedures.

The daily average came to 173.33 per day. As discussed, when the days were added up for 4 days per week, the number of days were extended nine additional days due to 9 weeks consisting of only 3 days of programming due to holidays, trainings, ½ days etc...
